

FA programme any more, because the expected cost reduction necessary as political justification for the realisation of the second stage of the programme has not yet materialised.

Even for the Brazilian-based industry which the government meant to protect by import duties, this situation is only a short-term advantage which in no way ensures a survival in the long run. With about 1.400 MW altogether, the first stage of PROINFA, without the market prospects of the second stage, is only a very limited market for the international wind industry, which because of the difficult economic situation of the projects probably will not even be fully exhausted.

For foreign manufacturers it is not exactly very tempting to think of setting up a wind turbine production in Brazil. A well-meant support programme is running the risk of falling flat, because it wasn't thought through properly. In view of the power shortages to be expected again in the future, this is not exactly a long-term strategy. What's worse, the consumer has to pay for the electricity supported by PROINFA, without the additional benefit of new industrial investments and therefore the creation of new jobs.

tos dos projetos. A desagradável consequência desta situação já fica notável: dificilmente mais alguém fala sobre a segunda fase do PROINFA, porque a necessária redução de custos prevista e justificativa política para a realização da segunda fase do programa não se materializou ainda.

Até mesmo para a indústria instalada no Brasil, que o governo teve a intenção de proteger através das obrigações de importação, esta situação é apenas uma vantagem de curto prazo e que de maneira nenhuma assegura uma sobrevivência no longo prazo. A primeira fase do PROINFA, com aproximadamente 1.400 MW ao todo, sem o mercado potencial da segunda fase, é apenas um mercado muito limitado para a indústria eólica internacional e que, por causa da difícil situação econômica dos projetos, provavelmente não vai nem mesmo ser esgotado completamente. Para os fabricantes estrangeiros não é exatamente muito tentador pensar em implementar a produção de turbinas eólicas no Brasil. Um programa de apoio bem intencionado está correndo o risco de falhar, devido ao fato disto não ter sido pensado corretamente. Em vista da recorrente escassez de energia esperada para o futuro esta não é exatamente uma estratégia no longo prazo. O que é pior, o consumidor tem que pagar pela eletricidade gerada dentro do PROINFA, sem o benefício adicional de novos investimentos industriais e, portanto, a criação de novos postos de trabalho.

Because of the rapid development of wind energy use in the past few years there has also been a strong increase in the demand for comprehensive information.
